What information do we collect?

- We collect email addresses.
- Registration: To enter the trade pages, purchase online, or to receive our newsletter, we ask you to register, and if you do we ask for your name, email address, geographical address and other personal and company information.
- From time to time we may ask you for further information, for example if you enter a competition.
- We may also use cookies. For an explanation, see the section on cookies below.

Use of Cookies

Cookies are small files, which many web sites transfer to your hard disk. They can inform the web site what pages you visit, and your preferences, which enable web sites to provide you with a more personalised service. You can set your browser to refuse cookies, or to warn you before accepting them.

We use cookies, but most parts of our site can be accessed even if your cookies are turned off. But you may find there are parts of the site that you cannot access or use fully, if your cookies are turned off.

How do we use your information?
